SSi Micro and Rogers implement North-South wireless roaming agreement for Canadian customers

SSi Mobile customers in Canada's North now benefit from Canada-wide coverage Rogers customers can now roam throughout Nunavut on Extended Coverage

YELLOWKNIFE, July 22, 2019. SSi Micro Ltd. and Rogers Communications Inc. announced today a new roaming agreement that ensures customers on both networks can roam worry-free.

For SSi Mobile, this means its customers in Northern Canada can travel to other parts of the country and enjoy a fast, reliable and consistent experience on Rogers wireless network. They can simply use their plan's minutes and data with no additional roaming fees.

"Our customers deserve the best possible service, whether at home, at work, or traveling outside Nunavut," said Jeff Philipp, founder and CEO of SSi. "As the only network operator with coverage in all 25 communities, SSi Mobile is growing quickly in numbers and popularity with consumers. This partnership with Rogers adds another level of excellence, ensuring the highest quality roaming connectivity across the country."

Rogers consumer and business customers who previously roamed only in Iqaluit can now roam on the SSi Mobile network while travelling to all 25 Nunavut communities for the first time in the company's history. The agreement provides seamless 4G-LTE and GSM connectivity on SSi's extensive northern network.

"Our consumer and business customers want high quality wireless access wherever they are, and we are committed to keeping Canadians connected, including in remote and rural communities," said Dean Prevost, President, Rogers for Business. "This agreement connects customers from both companies to the moments that matter most in their lives, whether it's travelling to or from Canada's North for business or pleasure."

The roaming agreement follows SSi receiving a spectrum sub-license from Rogers. Approved by Innovation, Science and Economic Development Canada (ISED), the spectrum allows SSi to create a larger block of radio frequency within the 1900MHz range to enhance wireless service in Nunavut and Yellowknife.

SSi is a pioneer in delivering remote-area connectivity in Canada's North and the developer-operator of the award winning SSi Mobile and QINIQ broadband services. SSi Mobile is the only cellular service with coverage in all 25 Nunavut communities and is the first-ever cellular service for sixteen of those communities. Startup Canada awarded SSi with the 2018 National High-Growth Entrepreneurship Award for the launch of SSi Mobile service in Nunavut.
